TYPES OF APPOINTMENTS

BOARDS AND COMMISSIONS

- Often not "full-time" positions or salaried
- Largely per diem or not compensated
- Slot restrictions, vary by board/commission
- May be subject to Senate confirmation
- Terms vary

FULL-TIME/ADMINISTRATIVE POSITIONS

- Full-time, salaried position
- Leadership position at department/agency
 - Legislative
 - External Affairs/Communications
 - Policy/Programs
 - Legal
- Serve at pleasure of the Governor
- Restrictions on outside employment/activities


